BOARD REPORT

Mike Brown

Even though the weather is beginning to get chillier, it's important to get some fresh air and exercise outdoors, especially as the pandemic continues to impact our lives. And what better place to take a walk, bike ride or run than our beautiful community.

BOARD ACTIONS:

- The Board voted on the following items:
 - 1. To award the initial consulting contract regarding possible clubhouse improvements to Design East Inc.
 - To proceed with purchasing both illumination kits for Little Lowell and Huxley Ponds, as previously discussed; both will be installed in early spring 2021.
 - To approve the Association's insurance contract renewal with Brown and Brown Agency.
- The Board instructed Klaas Kramer and Jack Lynn to meet with the Township and seek confirmation of the Board's recommendation regarding street tree replacement.
- The Board Secretary was instructed to include a "Neighborhood Safety" reminder (not to feed the wild animals) in the next Newsletter Board Report.
- The Board Secretary was instructed to resend the Election-related eBlast that had been sent previously.
- The Board authorized the transfer of \$150K from LOE's Operating Account to the Reserve Account, and the placement of \$166K into a Republic Bank CD.
- The Board instructed Associa to have a draft budget ready for discussion with the Board prior to October 9.
- The Board instructed Bill Harris to schedule a face-to-face meeting between the Board, the Outdoor Solutions owners, and Chris Norris to discuss rut problems in lawns and other related matters.
- The Board approved the following projects:
 - 1. Shrub replacement funding of \$5,000 for all ponds and \$3,000 funding for center

- islands 2 and 3, if Outdoor Solutions accepts our pricing for these two projects.
- 2. The arborist's contract for ash tree borer injections for all ash trees on common grounds at the \$1,300 fee. The arborist is also to be advised that the Board would like these injections every two (2) years.
- Adding a tab in the resident-only section of the LOE Website to include sale/ giveaway items from residents, as recommended by resident Norm Raditz. Procedures for posting will be developed by the Board in conjunction with the LOE Webmaster. Once ready, an eBlast will be sent to residents.
- The Board authorized Outdoor Solutions to proceed with previously discussed tree removal IF they honor pricing previously quoted.
- The Board President was advised to present five people to the Board who will serve on the Clubhouse Design Committee.
- The Board instructed Associa to obtain additional quotes for replacing the pool cover.
- The Board instructed Associa to make certain that the Election Committee is up to speed with Radburn law requirements in advance of the upcoming LOE election.

Reminders:

*Now that we have turned the clocks back and the days are getting shorter, please be aware of walkers/ runners/ bike riders when you drive through our community. Also watch for deer on roads at dusk and dawn.

*NO Contractor signs are permitted anywhere on your property or in windows.

The LOE election to fill open Board seats will be held in November. There is one (1) year position and three (2-) year positions. *BE SURE TO VOTE!!* Results of the election will be announced at the November 12 LOE ZOOM Community Meeting which begins at 7:30 p.m.

BROADCAST EMAILS

Email systems may treat LOE broadcast emails as spam. LOE broadcast emails can be delivered to your email inbox for a long period of time, even years, with no problem. However, email providers routinely change the addresses they treat as spam. If, for example, one or two LOE residents classify broadcast emails as spam, the provider may then treat all LOE broadcast emails as spam, no matter to whom they are sent. The result is that residents who use this provider do not receive broadcast emails. To avoid this, the LOE broadcast email address has to be placed in your contact list. If an email address is in your contact list, it will not be treated as spam.

The contact should read:

NAME: LOE Broadcast Email

EMAIL ADDRESS: loebroadcastemail@gmail.com

To avoid LOE emails going to spam, the email address <u>loebroadcastemail@gmail.com</u> must appear in the email address portion of the contact list in every personal device employed to access your email. Be sure the exact address is used.

You can always join a committee any time of the year! If interested, please call the committee chair whose phone numbers are in the monthly newsletter.

Architectural Review (ARC)

Reviews all forms submitted to the association manager for changes to resident's property. Review the new Homeonwer's Manual for details of how the process works. The application is reviewed and sent to the Board for approval.

Bereavement

Members assist when a resident or spouse passes by helping with a broadcast email and use of clubhouse for a gathering if wanted.

Civic

This committee is your eyes and ears around Evesham. They report on school issues, community development, roads, bridges, etc. and represent our community at area meetings.

Common Grounds

This committee monitors activities related to the common ground areas of the community such as fences, drainage ditches, roadway culverts and wetlands. It notifies the Board of any issues that affect the safety, aesthetics, and long-term viability of the community.

Facilities

The purpose of this committee is to be responsible for overseeing the maintenance of the clubhouse, pool, tennis and bocce courts, and horseshoe pit area. Along with the property manager, committee members make recommendations for general improvements and assist the Board in making decisions on vendor contracts.

Finance

The finance committee reviews the financials monthly and advises the Board. It also assists the Board with capital and operating budget development as well as long-term financial planning.

Helping Hands

Members send cards to those ill and hospitalized. They assist where rides are needed for doctor appointments,

pick up medicine or other needs. They also arrange for meals, if needed.

Landscape

Members work with our landscaper to confirm dates for the fertilizing, cutting and edging of our lawns and common grounds. They ensure all contractual terms are adhered to.

Library

This committee keeps our well-stocked clubhouse library in order. It is free to all to borrow any book. Donated and returned books should be left in the basket in the library. Donations of books with a copyright date of 10 years or less are appreciated.

Meet and Greet

Our new residents receive a welcome visit from members of this committee. Newsletter articles and photos (with the resident's approval) are written to introduce our new residents to the community.

Ponds

The job of this committee is to keep an eye on all ponds. Each pond has a representative who reports any pest activity and works to keep the aesthetics and long-term viability of the ponds.

Rules

At the request of the Board, this committee updates or adds rules to our Homeowner's Owners Manual. All revisions require Board approval. The community is updated when changes occur.

Social

All social events such as dances, entertainment and any other social function at the clubhouse are arranged by this committee.

Snow


The Snow Committee's job is to work with our private snow removal contractor and the Township to make sure our community is cleared in a timely manner. Snow removal commences when the depth is over 2 inches.

TREASURERS REPORT

Our financial position as of August 31, 2020 remains sound with an Operating Fund of \$342,526 and Reserve Fund of \$416,134.

As depicted by the graph, the variance between our projected and actual expenses of our operating funds for the year through August 2020 has stabilized.



The Board approved the transfer of \$150,000 from Operating Funds to the Reserve Fund which keeps the operating funds at \$200,000 to cover day to day expenses and any contingencies.

Most of our investments are in Money Market and CD accounts. Your Finance Committee looks for the highest return on these investments while ensuring that all our accounts remain government insured. During 2019 we were fortunate that our investment accounts offered up to a 2.5% yield. As a result, we realized \$10K to \$15K per year interest on these accounts. Unfortunately, these yields are now in the order of 0.5% or less with a corresponding reduction in interest income. Why am I telling you this? As I stated earlier, financially we are in excellent shape. However, I do not believe that our assets will continue to grow as they have in the past two years. The expected increase in costs of goods and services will also have an impact on our future financial position. After approaching 20 years, our community shows aging signs that may not have been identified in our reserve analysis, such as security systems, possible quinquennial maintenance of our trees including the services of an arborist, to mention a few. In regard to common grounds, your attention is directed towards the article in this newsletter on this subject.


Thanksgiving has always been a great time to gather family near and far. It's a time to give thanks for the blessings we have

LANDSCAPING

Fall flowers were planted at the front entrance, the islands and around the clubhouse. The colorful pansies will soon brighten the gardens and last throughout the winter. Look for fall cleanup to begin toward the end of October or early November, depending on when the majority of leaves fall.

Many residents are now scheduling the shutdown of their irrigation systems. If you want to continue watering for a while longer, *please turn off your irrigation system at least one day* (preferably two days if you have a severe drainage problem) *before Thursday's scheduled mowing*. This should help reduce the number of areas that cannot be mowed without causing turf damage.



COMMON GROUNDS

Legacy Oaks, surrounded by common grounds and wetlands, remains a desired community to live in. Its vitality is not only measured by resident involvement in committees and social activities, but also by the aesthetics of its common grounds. These common grounds consist of wetlands, ponds, main entrance, parking lots, tennis courts, clubhouse and swimming pool. During the year we enjoy new growth, appreciate the shade, and admire the change of colors of the various tree species. Unfortunately, last year we had to remove almost 40 trees. This was primarily due to emerald ash borer (EAB) infestation. This year, 40 additional trees will be removed, half due to the EAB infestation and the other half for various reasons such as soil incompatibility, tree rot, and mulch volcanoes. Although most trees will be replaced, those that have been planted too close to the wetlands or are encroaching on other healthy trees will not. The Board has taken action to prevent further decline in our tree inventory by enlisting

the services of an arborist. This was discussed in detail in the October Newsletter. Since receipt of the arborist's report (available for review on the LOE website), 26 ash trees have been injected with a chemical to prevent future EAB infestation. These injections will be required on a bi-annual basis. Soil samples were taken at various locations where new trees will be planted. Based on the laboratory analysis and recommendations from the Landscape and Common Grounds Committees, new trees will be selected and planted this year. According to the report, the most critical threat to the health and longterm viability of all common ground plants is overmulching, commonly called "mulch volcanoes." It is the cause of excessive stress, girdling roots, crown rot, and many premature plant deaths. The Board has taken actions to resolve this threat to our trees. Outdoor Solutions has been notified to prevent "mulch volcanoes" during future mulch applications. We are also in the process of obtaining proposals to remove these "mulch volcanoes".

How to save your tree

- Plant Correctly (Notice where the root branches out. Don't mulch above the line).
- · Dogwood planted incorrectly (Notice the "Volcano")

LOE is in the process of looking at ways we can refresh/refurbish the clubhouse and bring us current with other Senior 55 communities. The Board has hired a design company that has expertise in designing other senior communities' clubhouses. Their most current customer was Centennial Mills. We have organized our own Design Committee of five LOE residents to work with the designer.

When the final design and cost are available, we will present the proposal to the community for approval. The Board will then meet and make a final decision.




